

**MFG TCS London Marathon Terms and Conditions**

By applying for entry into the 2026 TCS London Marathon (the “Event”) in support of Metal For Good (MFG), I confirm I understand and agree to the following terms and conditions.

Registration and participation

1. I understand that to take part in the Event, I must register with London Marathon Events Ltd (the “Event Organiser”). Failure to complete the Event Organiser’s registration by any applicable deadline may mean I am unable to participate in the Event.
2. I understand that this Event is organised by the Event Organiser, who is solely responsible for the conduct and operation of the Event, including all health and safety requirements. I will read the Event Organiser’s Terms and Conditions for the Event and I will comply with any specific Event rules given by them.
3. I will be aged 18 years or over on the date of the Event.
4. If my application for a charity place in the Event, in support of MFG is successful, I will pay MFG within 5 working days of being offered a charity place, a non-refundable registration fee of £100.00 (the “Registration Fee”). The Registration Fee will be paid through bank transfer, in which details will be emailed to me by MFG to secure my place in the Event.
5. I acknowledge that I cannot swap, sell or transfer my place in the Event or allow anyone else to participate on my behalf.
6. I understand that MFG:
 - a. reserves the right to refuse my application for a charity place in the Event, as many applications are received beyond the number of places available. MFG is not obliged to notify me as to why my application has been refused; and
 - b. reserves the right to withdraw my charity place in the Event at any time in exceptional circumstances, including if I do anything that brings, or could bring, MFG reputation into disrepute or if I do not comply with these terms and conditions.
 - c. I will inform MFG Immediately by emailing hello@metalforgood.org if I am unable to take part in the Event. When my withdrawal is acknowledged by MFG I will not be liable to raise any further sponsorship.

Minimum fundraising target

7. I pledge to raise a minimum of £2,500 in aid of MFG, excluding Gift Aid and the Registration Fee (the “Minimum Fundraising Target”) through my participation in the Event. I understand the aim of this Event is to raise as much above the Minimum Fundraising Target as possible.



8. I understand that the sum of £2,500 must be paid to MFG by the fundraising deadline which is six weeks after the Event date (the "Fundraising Deadline").
9. If at any point I feel unable to raise the Minimum Fundraising Target, I will inform MFG immediately by emailing hello@metalforgood.org so that they can provide support with my fundraising plans.

Fundraising Target

10. I will use only lawful means to fundraise in aid of MFG and will not do anything that harms or is likely to harm MFG's reputation.
11. I will comply with any fundraising guidance or advice issued by MFG and abide by the Fundraising Regulator's Code of Fundraising Practice available here.
12. I will make clear to everyone supporting my fundraising that I am raising funds 'in aid of' MFG.
13. I will collect money in aid of MFG in connection with the Event only.
14. I understand that written consent must be sought from MFG by emailing hello@metalforgood.org prior to using MFG's name, branding or logos.
15. My fundraising will not include:
 - a. Raising funds by carrying out door-to-door or unsolicited collections.
 - b. Collecting funds in any public place without first obtaining written permission from MFG, a licence from the local authority and any other licences or consent as required by law and the Fundraising Regulator's Code of Fundraising Practice.
 - c. Collecting funds on private property (including shops, pubs etc.) without first obtaining written permission of the owner of the private property.
 - d. Conducting any raffle or lottery without first contacting MFG and following any steps required by MFG.
16. I agree that Gift Aid payments cannot count towards the fundraising pledge and instead will be considered funds raised over and above the Minimum Fundraising Target.

Donations and payment terms

17. All monies raised in aid of MFG are held on trust for MFG and I understand that I have a legal responsibility to ensure that all funds raised in connection with the Event are paid to MFG.
18. I will pay all monies raised in connection to the Event by one of the following means:
 - a. Via an online giving platform (such as JustGiving).
 - b. To MFG's bank account by using banking details provided by MFG (I understand these will only be made available upon request).



19. I understand that if the Minimum Fundraising Target has not been paid by the Fundraising Deadline, I may have to pay any shortfall from my own personal funds within one month of the Fundraising deadline date or in instalments to be agreed in writing with MFG.
20. I understand that if I withdraw for any reason from the Event, any monies raised will be non-refundable and will be treated as a donation to MFG payable in accordance with clause 22.
21. I will only use sponsorship forms issued by MFG. If I wish to use any other type of sponsorship form, I will seek prior written consent from MFG.
22. I will make it clear when fundraising in connection with the Event, that the money is not given subject to any conditions and that the funds will not be returned if the Event is cancelled, or I do not complete the Event.

Personal data

23. I understand that MFG will use the information provided by me when registering for the Event for the purpose of promoting and administering my charity place in the Event. MFG may also contact me to discuss my fundraising.
24. I give permission for my personal information to be passed on to the Event Organiser by MFG for the purposes of the organisation, promotion and administration of the Event.
25. The personal information provided by me when registering for the Event may be used for the purpose of sending me communications in line with the consent given when registering for the Event.
26. All personal data held by MFG will be handled and used in accordance with applicable privacy laws.

Health, safety and fitness

27. I understand that the Event will be physically challenging and there is a risk of injury. I will prepare myself for the physical challenge of the Event and I will obtain confirmation from my doctor to ensure that I am medically fit to participate in the Event. I confirm that I will not participate in the Event if for any reason I am not, or if I feel that I am not, in a fit state to take part and I confirm that it is my responsibility to seek expert medical advice if appropriate.

Liability

28. Nothing in these terms limits any liability which cannot legally be limited, including death or personal injury caused by negligence.
29. I understand that the activities and/or events I organise to raise funds in aid of MFG are my responsibility, including but not limited, to all costs and liability. MFG bears no liability whatsoever for any events and/or activities I may organise. MFG shall not be liable for any injury, damage or loss to me, my property or to any third party that might occur because of the fundraising activities and/or events that I organise.
30. I understand that I take part in the Event at my own risk, and I will not hold MFG or any connected persons, responsible for any accident, injury or illness to me, for any damage to my property, or for any losses that might occur because of my participation in the Event.
